SETTLEMENT AGREEMENT

You, C & F, Inc., were notified of a hearing before the Liquor Control Board (LCB) on June 12, 2013 at South Burlington, Vermont to consider the suspension or revocation of your liquor license(s) consistent with the Notice of Hearing dated May 9, 2013 and Department of Liquor Control (DLC) Ticket Number 0519.

You have offered to settle the violations alleged against you in the Notice of Hearing, specifically a violation of General Regulation No. 17, and the LCB has agreed to accept a fine of \$500.00 with the condition that if the fine is not paid in full by July 12, 2013, your First and Third Class Liquor licenses will be suspended for a period of seven (7) days beginning on July 13.
