- **Docket number 2017-007** Scott Reed, dba Hide-Away Tavern, 95 State Street, Rutland. Re: violation of general regulation number 17 (obvious signs of intoxication/remain on premise) **Licensee and Board reached an Agreement on 02/03/2017 Licensee will serve a 7-day suspension starting on opening of business February 16, 2017.**
- Agony LLC, dba The Local, 24 Merchants Row, Rutland. The Supreme Court dismissed their case on 02/13/17, therefore a motion to lift the stay of suspension that the Board granted should be lifted and the 21-day suspension should go into effect immediately. Motion carries. The Department will serve the suspension notice on the licensee today.
- **Docket number 2017-005** – Agony LLC, dba The Local, 24 Merchants Row, Rutland. Re: violation of 17, (displaying obvious signs) 17(a)-(2 counts-reasonable to expect), and 36(a) (brawls/fights). Licensee and counsel did not attend hearings today. They indicated that they wished to surrender the license and would not attend the hearing. The license has not been surrendered therefore the hearing will go on. A motion is made to continue with the hearing. Motion carries. Officer Damon Nguyen is called to testify and describes the brawl involving 50 to 75 people he encountered one night at 2:00 a.m. at the Local. Investigator Mike Davidson testifies concerning a bartender from the Local who was overserved there and then left the bar and was stopped for DUI. He also testifies to the elements that are showed on the DVD.

- **Docket number 2017-008** – Lake House Saloon, LLC, 67 Main Street, Barton. Re: violation of general regulation 9, (gambling), 17 (5 counts, allowing intoxicated patrons to possess), 17(a) (5 counts-serving to intoxicated patrons) and 36 (failure to control conduct).
