- Docket Number 2023-001: Einstein's Tap House LLC d/b/a Einstein's Tap House:
  - It is particularly alleged that on May 7th, 2022, at approximately 0040 hours, DLL Inv. Matthew Gonyo conducted an inspection of Einstein's Tap House located at 165 Church



Street in Burlington. During his inspection, Inv. Gonyo immediately noted an individual to be displaying signs of intoxication without being removed from the premises or being moved to a nonpublic area under the direct supervision of Licensee personnel, in violation of General Regulation 17. An Administrative Notice of Agency Action (#20220112) was issued to the licensee assessing a \$510.00 monetary penalty. The licensee denied that administrative ticket and has, therefore, requested a hearing before the Board of Liguor and Lottery

- Inv. Matthew Gonyo called in as witness for DLL and was sworn in.
- Inv. Matthew Gonyo explained his familiarity with Einstein's Tap House and Einstein's Tap House staffing.
- Around 12:40am May 7<sup>th</sup>, 2022 routine inspection of establishment was conducted by Inv.
  Matthew Gonyo. Matthew witnessed a male who was showing signs of intoxication,
  Matthew pointed out the male to an on-duty manager. A ticket for general regulation 16
  was issued to establishment electronically after the intoxicated male was escorted off
  premise.
