- Rare spirits raffle drawing scheduled for 12/10 ran into difficulties with vendor handling the draw, raised ~ \$55,000
- Sports wagering YTD is \$2.5 million in revenue share with 65% is coming from NFL betting
- Warehouse/ office is still in a competitive bid process
- Andrew Collier started his new position on Monday as Commissioner at DMV
- o Plan to have a New DLL deputy commissioner announced by the end of the year
- o Second annual customer satisfaction survey, twice the participation compared to last year
- o Lottery agents are the most satisfied and 802Spirits customers are the least satisfied
