# MARKETING AND SALES – Jeff Cavender

The Pollard contract is in the early stages and the initial draft is currently with the AG's office. Pollard Banknote will be coming to the Lottery on December 13<sup>th</sup> to talk about plans and strategies for the next 2-4years.

The Powerball PowerCruise 2 sole source contract with Alchemy 3 is at the Budget and Finance awaiting their approval.

There was a disclaimer added to the home page of the Problem Gambling website that lets the public know that CARTER is a private organization and not part of the Vermont Lottery.

The instant tickets are doing well. The reorder of the 40<sup>th</sup> anniversary \$5 and \$10 price points arrived yesterday. These additional tickets should last through March.

The new Fast Play Pro game called Green Mountain Jackpot has been launched. This game includes a \$2, \$5 and \$10 price points. This is the first time that a \$10 price point has been introduced and it has been very successful so far. There was \$160,000 in sales in the first 2 weeks of sales for the new game.

There is a site visit scheduled for December 5<sup>th</sup> at the Champlain Valley Fairgrounds to meet staff and contractors to determine what the space will ultimately look like for The Big Event.

The holiday TV spot was shown to the Commission.

### **CARTER** – Rick Barnett and Justin Wicks

Rick and Justin introduced themselves to the Commission. They gave a brief explanation of what they do, and updated the Commission on things that are happening within the organization and the trainings that they have attended as well as hosted.

# **INTRALOT** – Karl Fortman

Intralot completed the release for the Mega Millions game change and Green Mountain Jackpot. The first release of 2018 contains the iLook software for the sales reps iPads.

The WinStations are being rewrapped. The reskinning process will take place throughout the winter.

Intralot is also currently working on the TriState holiday promo scheduled for 12/17-23
